8. Rights and Limitations of members if not previously addressed:

THE CORPORATION HAS A SINGLE MEMBERSHIP CLASS; ALL MEMBERS BELONG TO THIS CLASS, AND ALL MEMBERS HAVE FULL VOTING RIGHTS.

9. Method of electing Trustees as set forth herein:

ELECTIONS SHALL BE HELD ANNUALLY BY MAJORITY OF MEMBERS, FOR THREE YEAR STAGGARED TERMS.

10. Asset Distribution:

UPON THE DISSOLUTION OF THE CORPORATION, ASSETS SHALL BE DISTRIBUTED FOR ONE OR MORE EXEMPT PURPOSES WITHIN THE MEANING OF SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE, OR THE CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE, OR SHALL BE DISTRIBUTED TO THE FEDERAL GOVERNMENT, OR TO A STATE OR LOCAL GOVERNMENT, FOR A PUBLIC PURPOSE.
